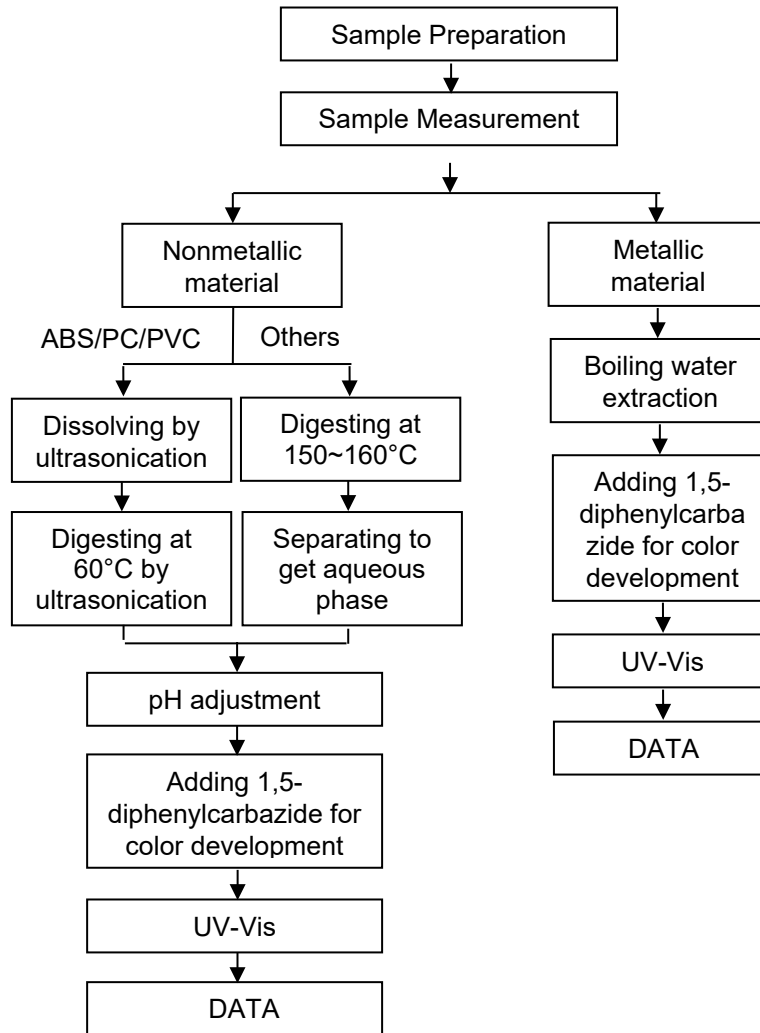
**Elements Testing Flow Chart**

These samples of Pb/Cd/Hg were dissolved totally by pre-conditioning method according to below flow chart.

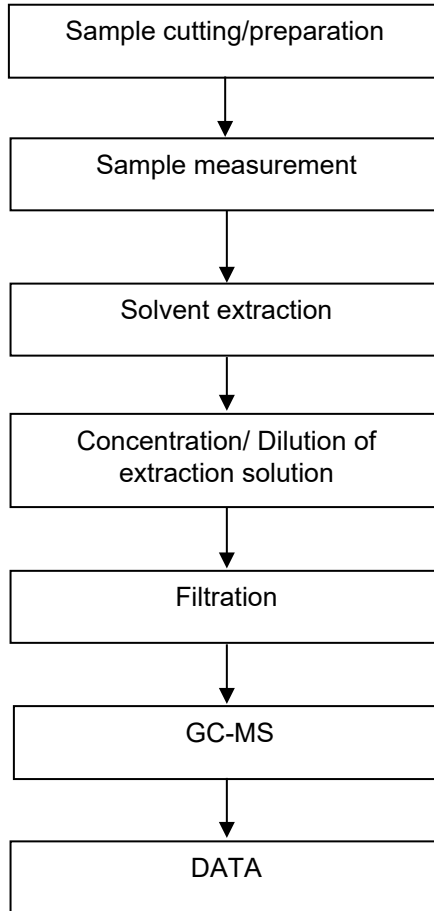

### Phthalates Testing Flow Chart



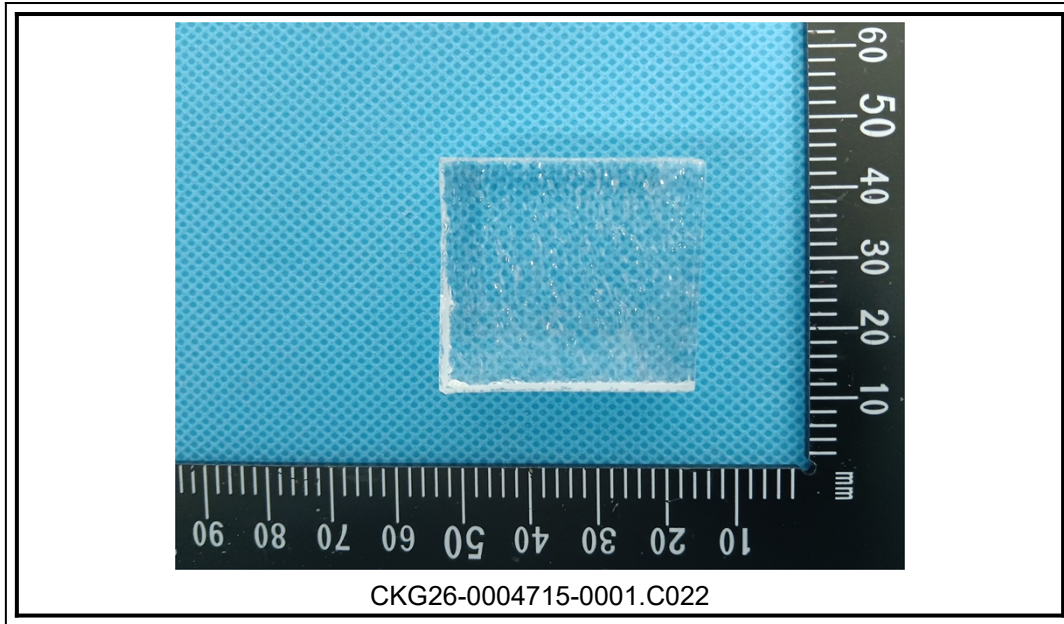
