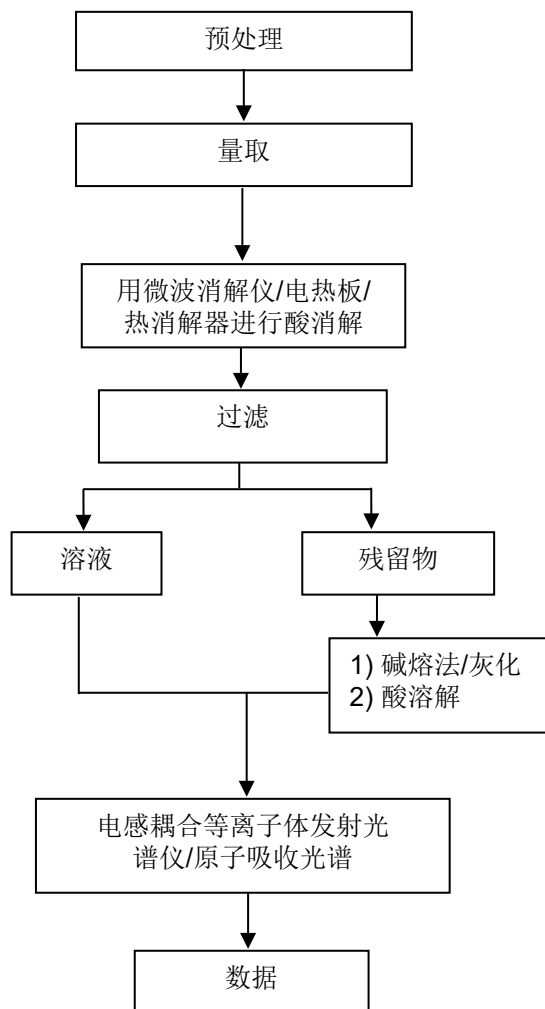

### 元素检测流程图

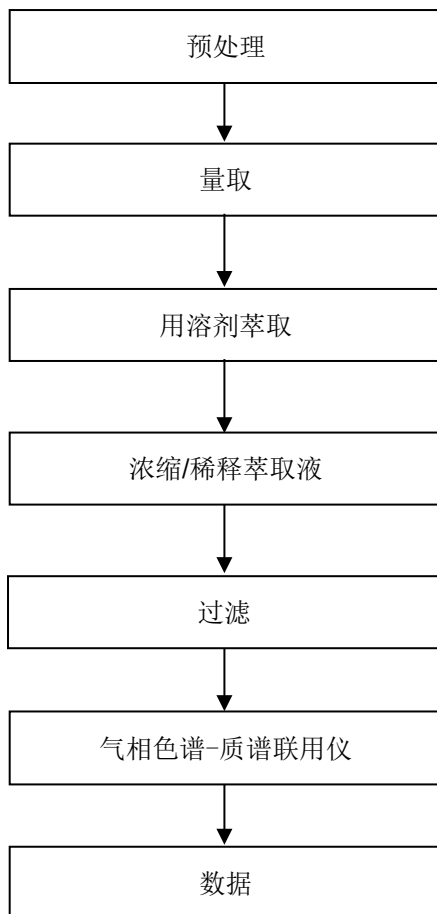

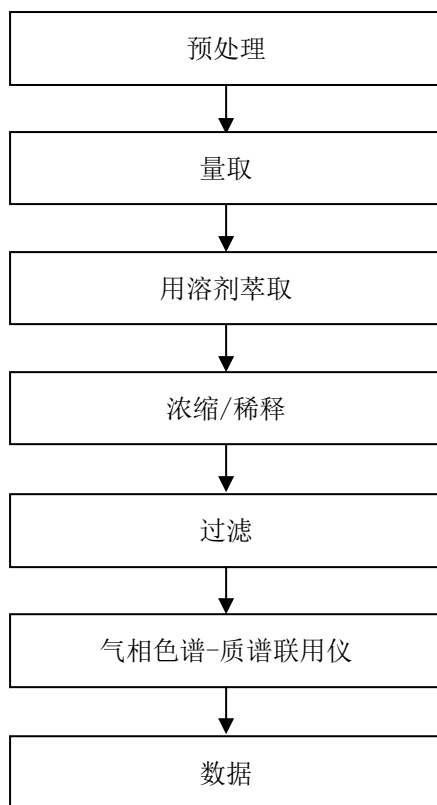
### 六价铬检测流程图

### Phthalates 检测流程图



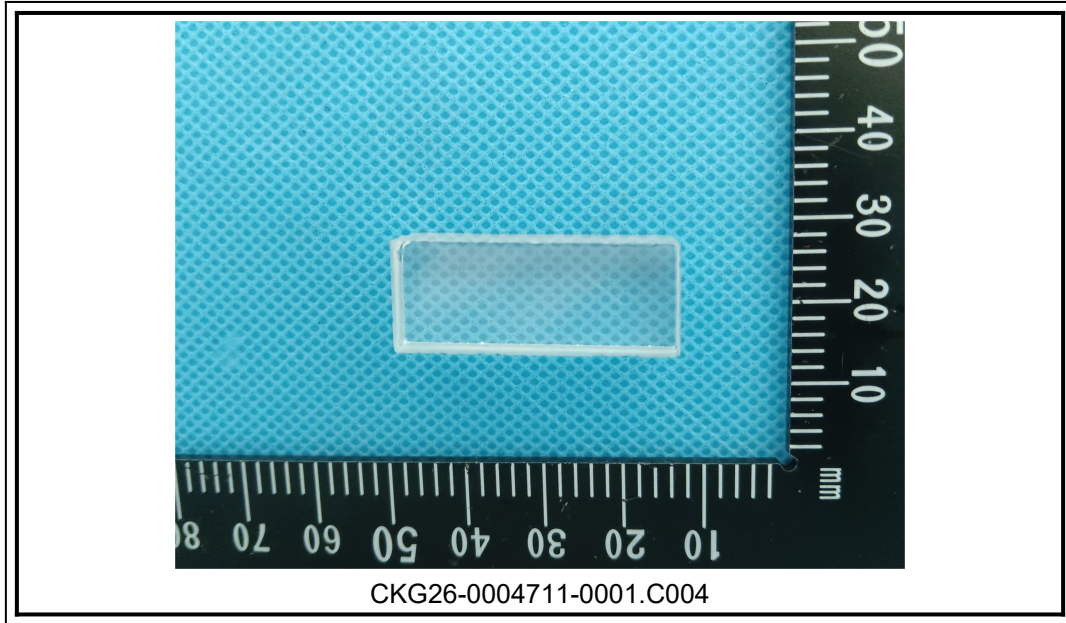
