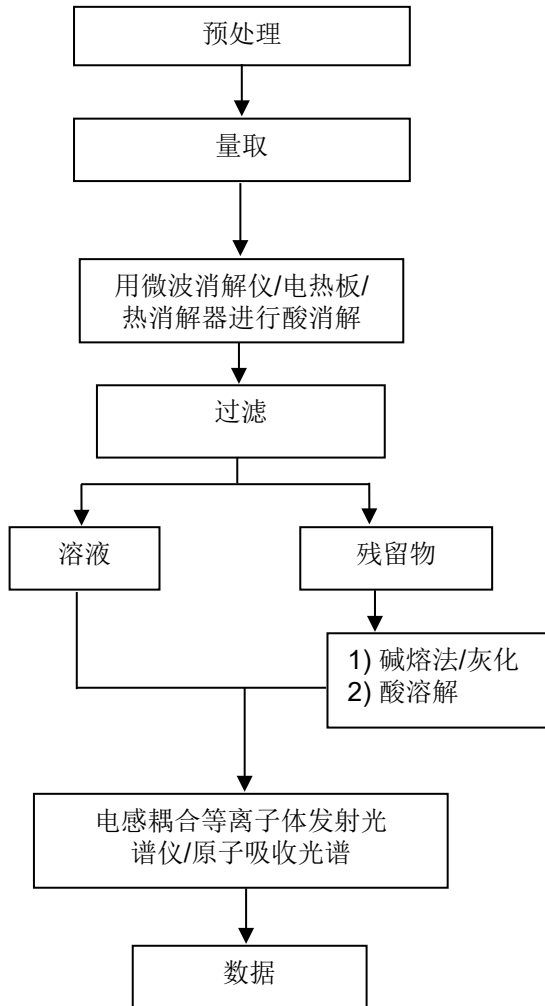

### 元素检测流程图

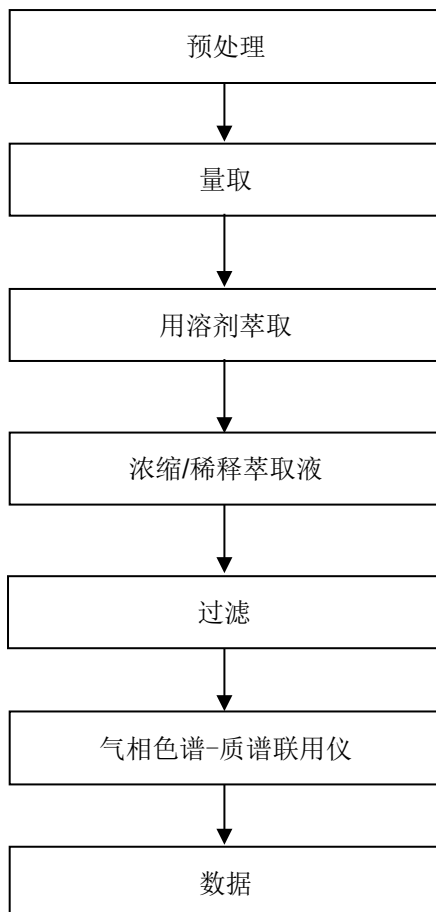
样品中的 Pb/Cd/Hg 按照下述流程被完全消解。



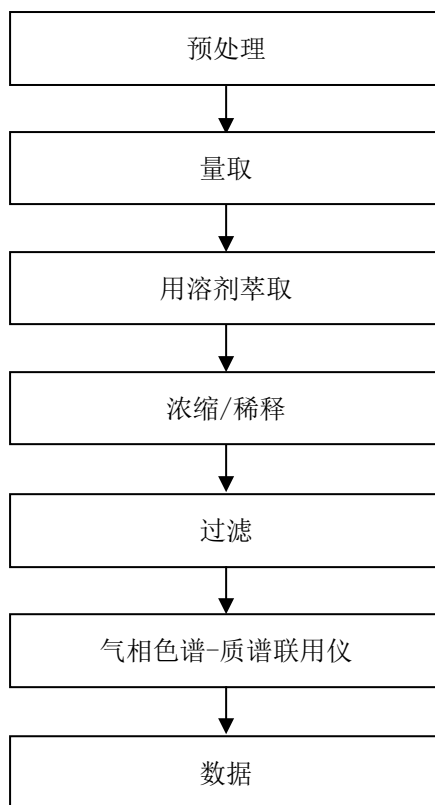
### 六价铬检测流程图

### Phthalates 检测流程图



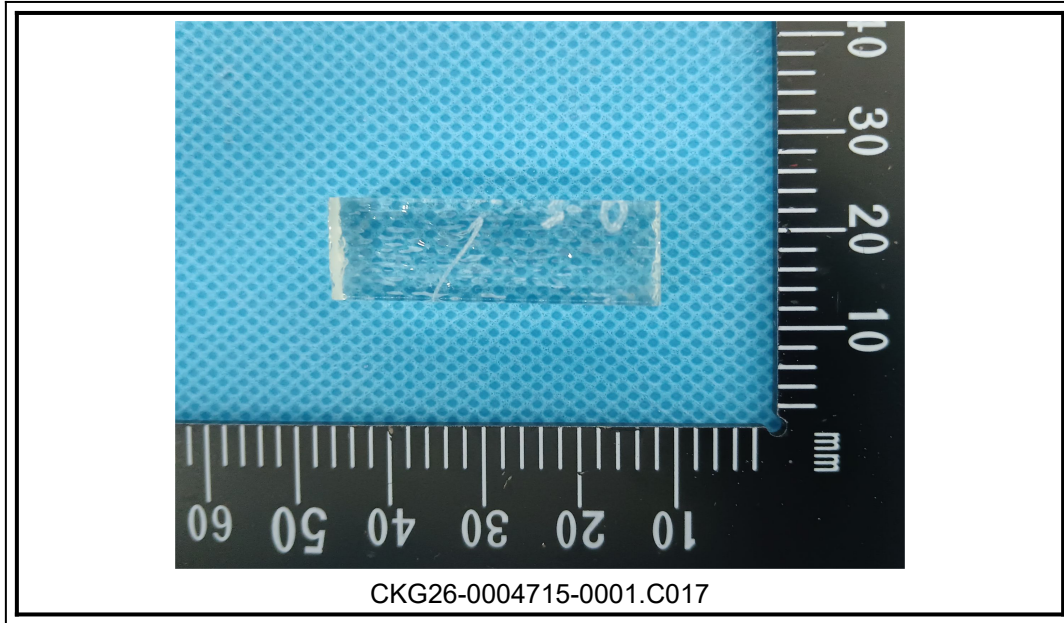
